The Edgar Township Board proposes to request a four thousand seven hundred fifty-two dollars and seventy-five cent (\$4,752.75) increase in the anticipated aggregate restricted funds from property taxes levied on its behalf for the 2015-2016 Budget. Such increase is greater than the increase permitted by Sec. 77-3446. "A vote FOR the proposal will allow the township to exceed the allowable growth percentage applicable to the lid and to increase the restricted funds base by 110.0% over the allowable growth percentage increasing the total anticipated aggregate restricted funds from property taxes levied by four thousand seven hundred fifty-two dollars and seventy five cents (\$4,752.75)." "A vote AGAINST the proposal will limit the Edgar Township Board to the increase permitted by Sec. 77-3446."

The Inland Township Board proposes to request a two thousand eighteen dollars and seventy-nine cents (\$2,018.79) increase in the anticipated aggregate restricted funds from property taxes levied on its behalf for the 2015-2016 Budget. Such increase is greater than the increase permitted by Sec. 77-3446. "A vote FOR the proposal will allow the township to exceed the allowable growth percentage applicable to the lid and to increase the restricted funds base by 50.0% over the allowable growth percentage increasing the total anticipated aggregate restricted funds from property taxes levied by two thousand eighteen dollars and seventy-nine cents (\$2,018.79)." "A vote AGAINST the proposal will limit the Edgar Township Board to the increase permitted by Sec. 77-3446."
