Notice is hereby given that on Tuesday the 8th day of November, 2022 **BY MAIL for ALL** election precincts of Clay County, Nebraska, an election will be held. The ballots must be returned to the Clay County Clerk's office by 8:00 p.m. on election day. Voters living in school districts that cross county lines will be voting on candidates and special issues in their respective districts. Proposed Amendments to the Constitution and Initiatives or Referendums will be published by the Secretary of State once each week for three consecutive weeks preceding the election. All terms are for 4 years unless indicated otherwise.
