## COUNTY BOARD OF SUPERVISORS

Courthouse, Clay Center, Nebraska, July 25, 2023, at 9:00 A.M.

The Clay County Board of Supervisors met July 25, 2023, as per public notice posted in the Clay County News on July 19, 2023, a copy of the notice being on file in the County Clerk's Office. Availability of the agenda was communicated in the advance notice of the meeting. Board Chairman L. Wayne Johnson presided with roll call showing the following present: Scott Bitterman, Eric Samuelson, Glen Becker, James Pavelka, Ivan Fintel, Dick Shaw and L. Wayne Johnson; Minutes of the meeting held July 18, 2023 were mailed to the board members. All the proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Board Chairman, L. Wayne Johnson stated that the open meeting law poster is posted on the west wall in the back of the room. All present stood for the Pledge of Allegiance.
