## COUNTY BOARD OF SUPERVISORS

Courthouse, Clay Center, Nebraska, August 29, 2023, at 9:00 A.M.

The Clay County Board of Supervisors met August 29, 2023, as per public notice posted in the Clay County News on August 23, 2023, a copy of the notice being on file in the County Clerk's Office. Availability of the agenda was communicated in the advance notice of the meeting. Board Chairman L. Wayne Johnson presided with roll call showing the following present: Scott Bitterman, Eric Samuelson, Glen Becker, James Pavelka, Ivan Fintel, Dick Shaw and L. Wayne Johnson. Minutes of the meeting held August 22, 2023, were mailed to the board members. All the proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Board Chairman, L. Wayne Johnson stated that the open meeting law poster is posted on the west wall in the back of the room. All present stood for the Pledge of Allegiance.

Motion by Pavelka and seconded by Fintel to approve the minutes of the meeting held August 22, 2023, as mailed. On roll call, yea: Samuelson, Becker, Pavelka, Fintel, Bitterman and Johnson; abstain: Shaw. Motion carried.

There was no public input.

Chairman Johnson read the monthly report of Weed Superintendent.

Thomas Roemmich II, Highway Superintendent: provided his weekly road report.

Haley Malone, Emergency Manager, came to discuss getting a vehicle for Emergency Management from the Federal Surplus in Lincoln. Motion by Fintel and seconded by Pavelka to purchase a 2016 Chevrolet Tahoe from the Federal Surplus in Lincoln in the amount of \$31,000.00 and authorize Haley Malone or Thomas Roemmich II to sign the purchase agreement with the agreement that the Emergency Management Department will surplus the 2 pickups and suburban from their Inventory and get rid of the Communications Mobile Operations Unit. On roll call, yea: Becker, Pavelka, Fintel, Shaw, Bitterman, Samuelson and Johnson. Motion carried.

Mark Johnson, Custodian, provided his monthly report and preliminary budget request for the 2023-2024 Fiscal Year.

Jennifer Fleischer, Clay County Attorney, discussed CPI Easement and advised that Roemmich make a request for revisions for review at the next meeting; no action was taken on School Creek Township.

The requests from the townships, fire districts and Ag society for preliminary levy requests were presented and discussed. Motion by Bitterman and seconded by Shaw to approve the following inventories: Supervisor districts 1, 2, 3, 4, 5, 6 & 7: County owned property: Board of Supervisor's Board Room, Clerk, Assessor, Treasurer, County Court, Clerk of District Court, County Attorney, Veteran Service Officer, Clay County Extension, Zoning, Custodian, Emergency Manager, Communications Center, Health Department, Weed Department, Sheriff's Department and Highway Department and place on file in the County Clerk's office. On roll call, yea: Fintel, Shaw, Bitterman, Samuelson, Becker, Pavelka and Johnson. Motion carried.

Cassie Aksamit, County Clerk presented preliminary budgets for County Clerk, Register of Deeds and Election Commissioner, Board, Road Imp Bond, County Equipment Sinking, Misc. Sinking, General Fund/Misc., Visitor Promotion, Visitor Improvements, Road Buyback and Inheritance Tax.

Motion by Fintel and seconded by Samuelson to advertise the Notice of Budget and Budget Summary Hearing for 2023-2024 as soon as the final numbers are received from the County CPA. On roll call, yea: Shaw, Bitterman, Samuelson, Becker, Pavelka, Fintel and Johnson. Motion carried.

Wages were discussed. Motion by Bitterman and seconded by Fintel to move forward page 3 of the Proposed Compensation Increase for Clay County Departments as presented by the Wage Committee. The County Clerk will work these figures into the Budget and provide the same to the County CPA. On roll call, yea: Bitterman, Samuelson, Becker, Pavelka, Fintel, Shaw and Johnson. Motion carried.

Claims were submitted by the County Clerk to be reviewed.

Motion by Bitterman and seconded by Pavelka to approve the claims that were presented and authorize the County Clerk to pay from the appropriate funds. On roll call, yea: Samuelson, Becker, Pavelka, Fintel, Shaw, Bitterman and Johnson. Motion carried.
