COUNTY BOARD OF SUPERVISORS MEETING MINUTES

The Clay County Board of Supervisors met at the Courthouse, Clay Center, Nebraska on July 15, 2025 at 9:00 A.M., as per public notice given in the Clay County News on July 9, 2025 a copy of the proof of publication being on file in the County Clerk's Office. Availability of the agenda was communicated in advance notice of the meeting. All of the proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman L. Wayne Johnson stated that the open meeting law poster is posted on the west wall in the back of the room and presided with roll call showing the following present: Scott Bitterman, Eric Samuelson, Glen Becker, James Pavelka, Jesse Mohnike, Richard Shaw and L. Wayne Johnson.

All present stood for the Pledge of Allegiance.

Minutes of the meeting held June 25, 2025 were provided to the board members prior to the meeting. Motion by Mohnike and seconded by Pavelka to approve the minutes of the meeting held June 25, 2025. Tallgrass representative John Hladik met with the Board to provide a construction update on the CO2 pipeline project in Clay County. The majority of the project components are ahead of schedule.

Thomas Roemmich II, Highway Superintendent provided a report on the roads and the June mechanic's report. A renewal sign permit was presented to the Board for the City of Clay Center sign at the corner of Highway 6 and Highway 14 South. Motion by Shaw and seconded by Pavelka to approve the sign permit.
